INDEMNITY/HOLD HARMLESS I, on behalf of myself and/or my minor and/or our heirs, personal representative and/or assigns also agree to indemnify and hold Lake Travis Independent School District (LTISD) and/or Lake Travis High School (LTHS) as well as their affiliates, parents, students, employees, contractors, volunteers or any person or entity associated in any way with the ownership, operation or affiliation with the tournament or facilities and the creation, production or distribution of Lake Travis High School (LTHS) related marketing content on any lake Travis Independent School District (LTISD) or Lake Travis High School (LTHS) website, harmless from any and all claims, causes of actions, lawsuits, arbitration or proceedings as well as from any expenses, judgements, costs, fees, damages, expenses and/or liabilities, including attorneys' fees incurred in defending or prosecuting any such claims brough against Lake Travis Independent School District (LTISD) and/or Lake Travis High School (LTHS) as a result of my or my minor's participation in the activities. I hereby allow Lake Travis High School (LTHS) to use my or my minors image or likeness without current or future compensation for marketing purposes related to LTHS.
- 3. RELEASE/WAIVER In consideration for being permitted to participate in the LTHS 3v3 tournament, I on behalf of myself and/or my minor and/or our heirs, personal representative and assigns HEREBY RELEASE, WAIVE AND DISCHARGE Lake Travis Independent School District (LTISD) and/or Lake Travis High School (LTHS) from any and all liability associated with or related to my or my minor's participation in the Activities and agree NOT TO SUE Lake Travis Independent School District (LTISD) and/or my or my minor's participation in Lake Travis High School (LTHS) for any reason resulting from or associated with the Activities. This waiver and release is intended to include all claims for injuries accidents, illnesses, or property loss, whether known or unknown or anticipated or unanticipated, which are in any way related or associated with the Activities.
- **4 NO INSURANCE** I, on behalf of myself and/or my minor, acknowledge that lake Travis Independent School District (LTISD) nor Lake Travis High School (LTHS) does not carry insurance on behalf of myself or my minor
- **5 LEGAL RIGHTS** I, on behalf of myself and/or my minor, understand and acknowledge that I/we are surrendering valuable legal rights in this agreement.
- **6. SEVERABILITY** I, on behalf of myself and/or my minor, understand an expressly agree that this agreement is intended to be as broad and inclusive as permitted by the law of held State for which it is used and that if any portion of this agreement is held invalid, shall be interpreted and construed toa afford as much protection to Lake Travis Independent School district (LTISD) and/or lake Travis High School (LTHS) as permitted by the applicable law.
